As regards to such candidates in the supplementary lists of other backward classes, their register numbers will be deleted from the short list without further notice, if they fail to produce the Non Creamy Layer Certificate. SC/ST candidates shall produce the Community Certificate obtained from Revenue authorities not below the rank of Tahasildar as specified in the Kerala Gazette.

- 6) According to existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts only **after publication of the Ranked List**. The details will be published along with the Ranked List.
