Note :- (6) Candidates belonging to Other Backward Classes included in this list who are required to produce Non - Creamy Layer Certificate as per G.O (MS) 5/14/SC/ST/DD dated 31.01.2014 shall produce the same along with the other documents mentioned above at the time of verification of original documents.

Note :- (7) **Candidates belonging to SC/ST in the list shall produce community certificate [Community certificate issued under Rule 4 of the Kerala (Scheduled Caste & Scheduled Tribe) Regulation of issue of Community Certificate Rules, 2002]obtained from the Revenue Officer not below the rank of Tahsildar.**
