- 3. Candidates whose register numbers are included in the short list are directed to send self attested copies of documents to prove their claims made in the application, i.e. qualification, date of birth, Community and other benefits if any, to which they are entitled, to the District Officer, KPSC District Office, SC/ST Development Corporation Building, II Floor, Opp. Town Hall, City Post Office, Chembukkavu, Thrissur 680 020 within 15 days from the date of publication of this notification. The register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Short List without further notice.
- 4. The candidates who have secured **79 (Seventy Nine)** marks and above are included in the Main List of the Short List. The requisite marks have been lowered to the extent necessary in respect of the candidates included in the supplementary lists.
- 5. The candidates belonging to the other backward classes included in the Short List except SC/ST candidates are required to produce Non- Creamy Layer Certificate as Per GO(P) No. 81/2009/SC/ST DD dated 26.09.2009 along with other documents. Such candidates in the Main List who fail to produce the required Non-Creamy Layer Certificate/ Community Certificate will not be entitled to the benefit of Community Reservation and will be considered as Open Competition Candidates. As regard to such candidates in the Supplementary Lists of Other Backward Classes, their Register Numbers will be deleted from the Short List without further notice, if they fail to produce the Non-Creamy Layer Certificate/ Community Certificate. (SC/ST candidates shall produce Caste Certificate obtained from Revenue Authorities not below the rank of Tahsildar as specified in Kerala Gazette along with other documents).
- 6. The place, date and time of interview will be intimated in due course.
- 7. According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be re-checked only after the publication of the Ranked List.
