- (7) Copy of answer scripts of the OMR Test held on 03/09/2014 will be issued to those candidates who, apply for the same remitting the prescribed fee after publication of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Invalidation Notification No : ER II(3)873/15/EW(9) dated 20.11.2015.
