The Register Numbers of those candidates who do not produce the required documents in person at the time of verification and whose application are found otherwise defective will be deleted from the Short List without further notice.

SC/ST candidates included in the Short List are required to produce two copies of Community Certificate issued by the Revenue Authority for producing before the Public Service Commission.

The candidates belonging to Other Backward Classes included in the Short List, who are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/STDD dated 26.09.2009 or G.O (P) No.13232/F3/SC/STDD dated 05.10.2009 shall produce the same along with the other documents mentioned above as and when called for. Such candidates in the Main List who fail to produce the required Community Certificate/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates and such candidates who are included in the supplementary lists will not be considered for this selection if they fail to produce NCLC/CC as the case may be.

The date, time and place of interview will be intimated in due course. According to the existing procedure, revaluation of answer script is not allowed. But candidates can apply for rechecking of their answer script after publication of the Ranked List for the post. Detailed instructions will be found in the Ranked List notification for this post.
