Such candidates in the Main List who fail to produce the required Non – Creamy Layer Certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competittion candidates. As regard to such candidates in the Supplementary Lists of various communities including SC/ST, their Register Numbers will be deleted from the Short List without notice. if thev fail produce Non-Creamy further to Laver Certificate/Community Certificate.
