Note:- (4) Candidates included in the Short List should produce original and self attested copies of the documents for Verification and present for the subsequent Interview. Date, Time and Venue of document Verification and Interview will be intimated later.

Note:- (5) According to the existing procedure, revaluation of Answer Scripts is not allowed but answer scripts can be rechecked after publication of the Ranked List. Candidates can apply for Re-checking/ Photocopy of the Answer Scripts by paying ₹ 75/- (Rupees Seventy Five only) as Re-checking Fees and ₹ 300/- (Rupees Three Hundred only) as Fees for Photocopy of the Answer Scripts. Detailed instructions will be published in the Ranked List to be published for the Post.

Note:- (6) SC/ST candidates included in the Short List are required to produce two copies of the Community Certificate issued by the Revenue authority and the candidates belonging to Other Backward Classes who are required to produce the Non-Creamy Layer Certificate as per G.O (P) No. 81/09/SC/STDD dated 26-9-2009 shall produce the same along with other documents mentioned above at the time of Verification of original documents.
