- (6) Candidates included in this list who are required to produce Non-Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents.
- (7) Copy of answer scripts of the OMR Test held on **03/09/2014** will be issued to those candidates who, apply for the same remitting the prescribed fee after publication of the Ranked List.
