Note 1. Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of applications on absolute basis. Note 2. The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage. The candidates who have secured 36 (**Thirtysix**) marks and above are included in the Main List of this Short List. The marks have been lowered to the requisite extent in respect of the Supplementary list.

Note 3: Candidates included in the short list published on 12.03.2014 who were absent and not eligible in practical test are excluded from this short list. Candidates who have attended the practical test conducted from 21.04.2014 to 28.04.2014 need not appear for the practical test and Document verification again.

SC/ST candidates included in the Short List are required to produce two copies of Community Certificate issued by the Revenue Authority for producing before the Public Service Commission and the candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST DD dated 26.09.2009 along with the other documents mentioned above. Such candidates in the Main List who fail to produce the required Community Certificate/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. The date, time and place of practical test and interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking/photocopy of their answer scripts within 45 days from the publication of the Ranked List for the post. Detailed instructions will be found in the Ranked List notification for this post.

Candidates are also advised to refer invalidation Notification No. ER VI (2)925/2012/EW dated 12.03.2014.
