Such candidates in the Main List who fail to produce the required Community Certificate/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates and such candidates who are included in the Supplementary lists will not be considered for this selection if they fail to produce NCLC/Community Certificate as the case may be.

The date, time and place of interview will be intimated in due course. According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking/photocopy of their answer scripts within 45 days from the publication of the Ranked List for the post. Detailed instructions in this regard will be found in the Ranked List notification for this post.

Copy of the answer scripts of the OMR Test held on 22.09.12 will be issued to those candidates who apply for the same, remitting the prescribed fee, after publication of the Ranked list.
