Such candidates in the Main List who fail to produce the required community Certificate, Non – Creamy layer Certificate will not be entitled to the benefit of community reservation and will be considered as open competition candidates.

Copy of the answer scripts of the OMR test held on 19.01.2012 will be issued to those candidates who apply for the same remitting the prescribed fee after publication of the Ranked List.
