Such candidates in the main list who fail to produce the above mentioned community/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered open competition candidates. The date, time and place of interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking/photocopy of their answer scripts within 45 days from the publication of the Ranked List for the post.
