The Register numbers of the candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Short List without further notice.

SC/ST candidates included in the Short List are required to produce Two copies of Community Certificate issued by the Tahsildar concerned indicating that the same has been issued to produce before Kerala Public Service Commission.

The Candidates belonging to Other Backward Classes included in the Short List, are required to produce Non-Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD Dated 26.09.2009 along with other documents mentioned above as and when called for. Such candidates in the Main List who fail to produce the required Community Certificate/Non Creamy Layer Certificate will not be entitled to the benefits of community reservation and will be considered as Open Competition candidates and such candidates who are included in the supplementary lists will not be considered for this selection for this selection if they fails to produce NCLC/CC as the case may be.

The date , time and place of interview will be intimated in due course.

According to the existing procedure, revaluation of answer Scripts

is not allowed. But candidates can apply for rechecking of their answer scripts after publication of the Ranked List for the post. Detailed instructions will be found in the Ranked list notification for the post.

Applications for rechecking received from candidates whose answer scripts have been invalidated will not be considered.
