- Note.5. Candidates included in the list should produce Community Certificate (original and two self attested copies) obtained for the purpose from Tahasildar along with other documents mentioned above at the time of Physical Efficiency Test.
- Note 6. According to the existing procedure, revaluation of answer scripts is not allowed, but answer script can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.
- Note.7. Copy of the answer scripts of the OMR test held on 29.12.2012 will be issued to those candidates who apply in the prescribed form for the same remitting the prescribed fee after the publication of Ranked List. Candidates whose Register Numbers are invalidated are advised to refer Notification No.ER XII/6482/13/EW dated 10.01.2014. They are not considered for inclusion in the list.
