with the other documents mentioned above as and when called for. Such candidates in the Main List who fail to produce the required community Certificate,

Non – Creamy layer Certificate will not be entitled to the benefit of community reservation and will be considered as open competition candidates.

The date, time and place of Interview will be intimated in due course.
