Such candidates in the Main List who fail to produce the above mentioned Community/NCL Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. The date, time and place of original documents verification and interview will be intimated in due course.

Note 4. According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking/photocopy of their answer scripts within 45 days from the publication of the Ranked List for the post. Detailed instructions will be published in the Ranked List to be published for the post.
