O (P) No. 117/08/SC/ST DD dated 19.12.08** or **GO (P) No.81/09/SC/ST/ DD dated 26.09.09** along with the documents mentioned above. Such candidates in the main list who fail to produce the above mentioned community/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as open competition candidates. The date, time and place of interview will be intimated in due course.
