SC/ST candidates included in the Short List are required to produce 2 (two) copies of Community Certificate issued by the Revenue Authorities for producing before the PSC and the candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009, along with the other documents at the time of verification. Such candidates in the Main List who fail to produce above mentioned Community/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the Suplementary List, their Register number will be deleted from Short List without further notice.

The date, time and place of interview will be intimated in due course.

Note 4. According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking/photocopy of their answer script within 45 days from the date of publication of the Ranked List for the post. Detailed instructions in this regard will be found in the Ranked List notification for the post.
