The following is the list of candidates found suitable by the Commission on the basis of Objective Type (OMR valuation) Test held on 06.05.2017 and the verification of original documents of candidates included in the Probability List published on 08..08.2018 for selection to the post of **Lower Division Clerk (SR for SC/ST)** on Rs.9940-16580 in **Various Departments** in Malappuram District (Cat. No.122/2016) notified in the Gazette dated 14.06.2016 and arranged in the order of merit. The Ranked List is brought into force with effect from **10.10.2018**.

The Ranked List will remain in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time , if applicable.,against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies,there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

The entries put in column 8 are based on the communities specified by the candidates in their application and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the District Officer, Kerala Public Service Commission District office, Malappuram within one month from the date of publication of the list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of **Rs.80**/- (Rupees Seventy Five only). The fee should be remitted in any one of the Treasuries in the State under the Head of Account **"0051- PSC- 105 STATE PSC - 99 EXAMINATION FEE"** and original Chalan should be enclosed with the application. Application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website/ **www.keralapsc.gov.in** or photocopied there from. Applications submitted in any other manner will

not be considered. The original Chalan receipt together with the application for rechecking should reach the District Officer, K.P.S.C District Office, Malappuram within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fee of **Rs.315**/- in any of the Treasuries in the State. **Head of Account 0051 -PSC- 800-State PSC- 99 Other receipts)**. The duly filled up application in the prescribed form (available from the Commission's Website **www.keralapsc.gov.in**) along with the original Chalan should be submitted to the District Officer, KPSC District Office, Malappuram within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR Sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is **23/11/2018**. Applications received after the prescribed date will not be entertained.

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearingh photograph as enlisted in the General Conditions". The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

Valid applications for rechecking/ photocopy of answer script addressed to District Officer, K.P.S.C District Office, Malappuram shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking/ photocopy of answer script is **23/11/2018**. Application for rechecking/ photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
