NOTIFICATION

The following is the Ranked List of candidates for selection to the post of **Lower Division Clerk/Village Assistant (Special Recruitment for Differently Abled candidates) in Land Revenue Department in Thrissur District**, notified in the Gazette dated 11.11.2016 (Category No.413/2016) on Rs.19000-43600/- found suitable by the Commission and arranged in the order of merit based on the OMR Test held on 06.05.2017. The Ranked List is brought into force with effect from 16.08.2018.

This Ranked List is intended to make recruitment to the backlog vacancies of Differently Abled candidates during the period from 01.01.2004 to 31.12.2007 as earmarked for the various categories of Physically Handicapped as per G.O.(P) No.7/2011/SWD dated 24.01.2011 and will remain in force for a maximum of three years subject to the conditions that the Ranked List will cease to exist as and when candidates are advised and appointed against the above mentioned backlog vacancies. Rules 14 to 17 of Part II, KS & SSR are not applicable to this selection. Candidates will be advised and appointed against vacancies notified and also against the backlog vacancies, if any, reported by the appointing authorities of Land Revenue Department as earmarked in the above mentioned order.

NOTE I :-

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fee of Rs.300/- in any of the Treasuries in the State (Head of account: 0051 PSC-800-State PSC-99 other receipts). The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to The District Officer, Kerala Public Service Commission District Office, Thrissur within 45 days from the date on which this ranked list is brought into force. A copy of an answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipts of applications is 29.09.2018. Applications received after the prescribed date will not be entertained.

NOTE II:-

A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is brought into force. The candidates can avail only one chance.

“Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered”

The application for rechecking, along with original chalan receipt for the prescribed fee of Rs.75/- under the head of account “0051-PSC-105 State PSC 99 -Examination Fee” addressed to The District Officer, Kerala Public Service Commission District Office, Thrissur should reach the office on or before. 29.09.2018. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not refunded.

NOTE III:-

“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal. An Affidavit certified by Notary and a self attested copy of photo affixed ID card. The request for relinquishment received within 15 days from the date of publication of the Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised”.
