NOTIFICATION

The following is the list of candidates found suitable by the Commission on the basis of the Objective Type (OMR) Test held on 31/01/2017 and Practical Test held on 03/05/2018 for selection to the post of Driver (HDV) NCA-VISWAKARMA in EXCISE DEPARTMENT in KANNUR DISTRICT (Category No. 153/2016) and arranged in the order of merit. The Ranked List is brought into force with effect from 26.07.2018.

The Ranked List thus published shall remain in force until candidates are advised and appointed against the vacancies earmarked for Viswakarma Community but remained unfilled due to the paucity of candidates during the currency of the Ranked List published for the post on 26/11/2013 (Cat.No. 118/2007). As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in this list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuation of Answer Script is not allowed. But re-checking of marks will be done on payment of Rs. 75/-. The fee should be remitted in any one of the treasuries in the State under the head of account "0051 PSC - 105 State PSC- 99 Examination Fee" and original challan enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website/ www.keralapsc.gov.in/ or photocopied therefrom. Applications submitted in any other manner will not be considered. The original challan receipt together with the application for re-checking should reach the District Officer, K.P.S.C District Office, Civil Station P.O, Kannur within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs. 300/- by way of challan in any of the treasuries in the State (Head of Account 0051 PSC-800 State PSC - 99 other receipts). The duly filled up application in the prescribed form (available from the commission's website) along with the original challan should be submitted to the District Officer, K.P.S.C District Office, Civil Station P.O, Kannur within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions” The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of ranked list. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.”

NOTE: I Since a common Written Test/ OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of OMR test and Practical Test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test.

NOTE: II The result of rechecking of OMR answer scripts will be intimated in due course, But photo copy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

Valid applications for rechecking/ photocopy of answer script addressed to District Officer, K.P.S.C District Office, Civil Station P.O, Kannur shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking/ photocopy of answer script is 10/09/2018. Application for rechecking/ photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
