The last date for receipt of applications is 22.12.18. Applications received after the prescribed date will not be entertained.
- Note (2) :- A period of 45 (forty five) days time to apply for rechecking of answerscripts will be allowed to candidates with effect from the date on which this ranked list is brought into force. The candidates can avail only one chance. "Applications for rechecking of answerscripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.gov.in or photocopied therefrom. Applications submitted in any other manner will not be considered." Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.
  - Note (3) Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of the State/Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an identity proof bearing a photograph as enlisted in the general conditions.. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the ranked list. After the publication of ranked list, the request for relinquishment will be considered only if such request is received on or before the date of requisition, based on which he /she is to be advised.
- Note (4) The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of Ranked List ie.on 08.05.2019.
