6. Age : 18-35, Only candidates born between 02.01.1978 and 01.01.1995 (both dates included) are eligible to apply for this post. Scheduled Castes, Scheduled Tribes and Other back ward communities are eligible for usual age relaxation.

Note:- The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in

the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the commission. It would also be clearly specified in the certificate that they are not working in the regular service of the concern.

- **Note:** 1. In the absence of candidates with qualifications mentioned as in items (1),(2) and (3) candidates possessing qualifications 1 and 2 alone will be selected and sent for training. Such candidates will have to execute a bond to serve the Board for a period of five years after training.
 - 2. All candidates appointed by direct recruitment shall pass General Test on Khadi and Village Industries and General Test in Co-operation conducted by the Kerala Khadi and Village Industries Board during the period of probation.

8. Mode of submitting application:
