FIRST N.C.A. NOTIFICATION

Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

1. Name of the firm : State Farming Corporation of Kerala Ltd.
2. Name of Post : Work Supervisor
3. Scale of Pay : ₹ 3,350-5,275/-
4. Number of vacancies : Muslim -1 (One)

Note:- (i) The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancy earmarked to the Muslim community but remaining unfilled due to the paucity of candidates during the currency of ranked list published on 12.01.2011, based on the notification published in the gazette date 12.03.2008 Category No.108/08.

(ii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

5. Method of Appointment : Direct Recruitment.(From Muslim candidates only)

Note: The application submitted by candidates other than Muslim Community will be summarily rejected. Individual rejection memo will not be sent to those candidates.

6. Age : 18-38, Only candidates born between 2.1.1975 and 1.1.1995 (both dates included) are eligible to apply for this post.(Including relaxation in para 2(i) of General

Condition).

Note:- The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

7. Qualifications:

Diploma in Civil Engineering or equivalent qualification.

8. Method of submitting application:
