- (i) Post Graduate Degree in the respective discipline from a recognised University (Viz. MD/MS/DNB)
- (ii) Permanent Registration under State Medical Council (Travancore Cochin Medical Council)

In the absence of candidates with the above qualification candidates (from the communities mentioned in Column No. 4 of Para 2 above) with

- (i) MBBS Degree from a recognised University
- (ii) Permanent Registration under State Medical Council (Travancore Cochin Medical Council) will be considered for the post of Lecturer (salary as per the UGC Norms).
