Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

1. **Department** : Vocational Higher Secondary Education
2. **Name of post** : Vocational Teacher-Live Stock Management
3. **Scale of pay** : Rs.19240-34500
4. **Number of vacancy** : SC-1 (One) (Cat No 363/2014),  
ST-1 (One) (Cat No 364/2014)

The above vacancies are now in existence. The ranked list published as per this notification will be valid until candidates are advised and appointed against the above vacancies earmarked for SCs and STs, but remain unfilled due to paucity of candidates during the currency of the ranked list published on 17.04.2007 for the post.

5. **Method of appointment** : Direct Recruitment (from SCs and STs only)

**Note :-** The applications submitted by candidates other than SCs and STs will be summarily rejected. No rejection memo will be issued to those candidates.

6. **Age limit** : 23-45 Only candidates born between 02.01.1969 and 01.01.1991(both dates included) are eligible to apply for this post.

7. **Qualifications** : Degree in Veterinary Science and Animal Husbandry with not less than 60% marks from Kerala Agricultural University or an equivalent qualification.

- Note:-**
1. In the appointment of Vocational Teacher preference will be given to persons having additional qualification of Diploma in Computer Application from a recognised Institution.
  2. All the Educational qualifications for teaching posts should be one acquired after a

regular course of study from a recognised University in Kerala or recognised as equivalent thereto by any of the Universities in Kerala.

**8. Method of submitting Applications :-**

Before applying for the post, candidates shall register as per 'ONE TIME REGISTRATION' scheme through the Official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)'.
