- (i) Conventional type applications will be summarily rejected. Candidates shall apply online only by One Time Registration to www.keralapsc.gov.in.
 - (ii) A Ranked List will be prepared for each district in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
 - (iii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he or she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment

6 Age Limit : 18 – 40. (i.e, candidates born between 02.01.1974 and 01.01.1996 (both dates included) only are eligible to apply for this post. Other Backward Communities and SC/ST candidates are eligible for usual age relaxation.

Note:- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years of age, please see para (2) of the General Conditions under Part II of this Notification .

7. Qualifications:

1 A pass in SSLC Examination conducted by the Commissioner for Government Examinations, Kerala or its equivalent.

2 A pass in the Certificate of Physical Education issued by the Commissioner for Government Examinations, Kerala/Karnataka or Tamilnadu [GO (MS) No. 213/2010 G.Edn dated 1.11.2010] or a pass in the Vocational Higher Secondary Certificate Course in Physical Education conducted by the Board of Vocational Higher Secondary Educations, Kerala or its equivalent or any degree in Physical Education (Regular Course) such as B.P.Ed/M.P.Ed etc. conferred or recognised by any of the Universities in Kerala. [G.O(MS)No.48/2001/G.Edn. Dated 9.2.2001]. Ex -Servicemen of Army/Navy/Air Force who possess SSLC or its equivalent and any one of the following qualifications can also apply for the post.

“Physical Training Course of the Armed Forces” (The Assistant Instructors Basic Course in Physical Education).

OR

The Army Physical Training Corps Instructors Course.

OR

Naval Physical Training Corps Instructors Course.

OR

Air Force Ground Training Instructors Course.

Note:- Physically Handicapped persons are not eligible to apply for this post.

8. SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT

(i) Preference will be given as laid down in G.O.(MS) No. 50/70/PD dated 12.02.1970 and G.O.(MS) No. 9/78/G.Edn. Dated 21.01.1978 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the term `Jawans'. Wives of Jawans should note in the application that they are wives of Jawans. Such candidates should obtain proper certificates from the Officer Commanding stating the name, military rank and military address of their husbands and produce the same as and when required by the Commission (G.O (MS) No. 509/64/Edn. Dated 19.09.1964, G.O.(MS) No. 614/65/Edn. Dated 09.11.1965 and G.O (MS) No. 243/66/Edn. Dated 27.05.1966).

- (ii) Laboratory Attenders in the departmental High Schools in the State who have rendered at least 5 years satisfactory service and who possess the prescribed qualification will be exempted from age limit. They should produce proper certificates from the headmaster of the school specifying the date of commencement of their service and the total service put in by them as and when required by the Commission. The candidates who claim exemption on this will be considered only against vacancies to be filled up by open competition on the basis of merit alone (G.O (MS) No.315/62/Edn. Dated 14.05.1962)
- (iii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O (MS) No. 122/75/G.Edn. Dated 27.05.1975).

Note:- The candidates who claim concessions by virtue of the above or any reason mentioned in Para 2 of the General Conditions should state “Are you eligible for age relaxation” as “yes” on the online application and give details in the space following.

9. Last Date for receipt of applications :.16/04/2014 Wednesday upto 12.00 Midnight.

10. Mode of Sending Application :

Candidates must register as per “ ONE TIME REGISTRATION” on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' . Those who have registered shall apply by logging on to their profile using their user ID and password. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details on the registration card by clicking the link **Registration Card**. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile and they shall quote the User Id for further communication with the Commission. Application once submitted will be received as provisional and cannot be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.

11. Address to which applications are to be sent : www.keralapsc.gov.in.

12. If a Descriptive/OMR Test is conducted as part of the selection, Admission Ticket of eligible candidates will be made available in the website of the Kerala Public Service Commission. Candidates are instructed to download their Admission Ticket as per the instructions in the website.
