- iii. Candidates shall submit application for the post to the district where the vacancy is in existence and note the name of that district against the relevant column of the online application.
- iv. The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in GO(Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to

another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in GO(MS) No.4/61/PD dated, 2.1.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (from candidates belonging to LC/Anglo Indian community only)
6. Age Limit : 18-39. Only candidates born between 02.01.1974 and 01.01.1995 (both dates included) are eligible to apply for this post including the relaxation as per para 2 (i) of General Conditions.

**Note:-** For conditions regarding other age relaxations please see para 2 of the General Conditions except para 2(i).

7. Qualifications:

1. Pass in S.S.L.C or equivalent examination.
2. Diploma in Pharmacy
3. Registration with the Kerala State Pharmacy Council
