Applications should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction and if he/she is selected, his/her name will be removed from the ranked lists and disciplinary action will be taken against him/her. Candidates should note the name of the district concerned in the relevant column.

(iv) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in GO(MS) No. 154/71/PD dated, 27.5.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5years continuous service from the date of commencement of service in the former District. Even if transfer is allowed after 5 years, it will be subject to the rules in GO (MS) No.4/61/PD dated, 02.01.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment from candidates belonging to the above mentioned communities. In the absence of Scheduled Tribe candidates, applications of scheduled caste candidates will also be considered.

- Note:- (1) Certificates issued from Typewriting Institutions and IMC Certificates will not be accepted.
  - (2) Those who have passed KGTE Typewriting before January 2002 should produce separate certificate in Computer Word Processing or its equivalent. Certificate in Computer Word Processing issued by Central/State Government Departments, Agencies, Societies, Universities after successfully completing course of study not less than three months duration are considered as equivalent.
