- (i) Conventional type application will be summarily rejected. Candidates shall apply only through online application available at the Kerala Public Service Commission website.
 - (ii) Separate Ranked list will be prepared for each districts in pursuance of this notification. The Ranked Lists thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said lists will continue to be in force till the publication of new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier.
 - (iii) Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction and if he/she is selected his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her. Candidates should note the name of the concerned District against the relevant column of the online application.
 - (iv) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(MS)No. 4/61/PD dated, 02.01.1961.

Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. **Method of appointment** : Direct Recruitment.
6. Age limit : 18-36.
i.e only candidates born between 1.1.1996 and 2.1.1978 (both dates included) are eligible to apply for this post. Other Backward Communities and SC/ST candidates are eligible for usual relaxation.

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, Please see para (2) of the General Conditions under Part II of this notification.

7. **Qualifications:-**

- 1 A pass in SSLC or its equivalent qualification.
- 2 Must possess current Motor Driving license (light duty vehicles) atleast three years standing and Driver's badge.
- 3 Proficiency in Driving light duty vehicle to be proved through a practical test conducted by KPSC during the course of selection.

Note :- Proficiency in driving Light Duty Vehicles will have to be proved in a practical test including H.Test and Road Test. Those who pass H.Test are eligible for Road Test.

Note :-

- 1 Physically Handicapped candidates are not eligible to apply for the post.
- 2 Candidates should furnish the full details regarding the Driving Licence and experience in driving in the relevant column (qualifications) of the application form.
- 3 A practical test will be conducted for the selection to this post.
- 4 Candidates called for practical Test will have to produce a Medical Certificate in the prescribed form in original containing all relevant details as required in para 7 (4) (except 4(b) above from a Medical Officer not below the rank of an Assistant Surgeon. A Medical certificate regarding eye sight from an Ophthalmologist in Government Service also will have to be produced.

- 5 Candidates from the ranked list prepared in response to this notification will be advised for appointment as per turn against Head Quarters vacancies also.
- 6 Candidates should possess a current Driving Licence on the entire stage of selection process i.e on the date of application and on the date of written test, practical Test and Interview.

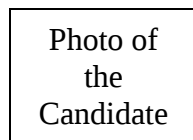
