1. Name of Firm : Kerala State Road Transport Corporation
2. Name of Post : Guard Gr.II (Ex serviceman only)
3. Scale of Pay : ₹ 865 - 1615/- (PR)
4. No. of vacancies : 02 (Two)

**Note:-**

- (1) The above vacancies existing at present. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the above community but remain unfilled due to the paucity of candidates during the currency of the Ranked List published on 31.12.2009 for the post based on the Notification published in the Gazette dated 12.11.2007 as Category No. 421/2007.
- (2) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall

terminate the service of the candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

5. Method of appointment : Direct Recruitment. Candidates belonging from LC/AI community.

Note: Application submitted by candidates other than LC/AI community will be summarily rejected. No rejection memo will be issued to these candidates.

6. Age : 18-48. (Only candidates born between 02/01/1966 and 01/01/1996 (both dates included) are eligible to apply for this post.

**Note:-** 1. . The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

Army, Navy or Air Force

**Note:** Physically Handicapped candidates are not eligible to apply for this post.

Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with
