Rules 14 to 17 of Part II, KS&SSR are not applicable to this selection.

Candidates will be advised and appointed against the above mentioned vacancies and also against the backlog vacancies, if any, reported by the Appointing Authorities as earmarked in GO(P) No 7/11/SWD dated 24/01/2011.

Selection to the above-mentioned vacancies will be made from among the PH categories found suitable for the post as per existing government orders and vacancies will be apportioned among these categories in the ratio 1:1:1.

5. Method of Recruitment : Direct Recruitment through the Public Service

Commission from among the qualified Laboratory Technicians in the Medical Education Services belonging to the category of persons with disability → (Direct recruitment from (PH-Locomotor Disability/Cerebral

palsy, Hearing Impairment and Low Vision)

In the absence of qualified hands for recruitment from Laboratory Technicians, the vacancy will be filled up from Open Category candidates.(PH) <u>Note</u>:- Application submitted by candidates other than those belonging to PH (Locomotor disability/Cerebral palsy, Hearing impairment and Low vision) category will be rejected. Individual rejection memo will not be sent to them.

- **6. Age** : There will be no upper age limit for 'in-service' candidates.
 - i). Locomotor disability/Cerebral palsy: 18-46: Only candidates born between 02.01.1968 and 01.01.1996 (both dates included) are eligible to apply for this post
 - ii) *Hearing impairement and Low Vision*: 18-50: Only candidate born between 02.01.1964 and 01.01.1996 (both dates included) are eligible to apply for this post.
