- 6 Age limit** : 20-36. Only candidates born between 02.01.1978 and 01.01.1994 (both dates included) are eligible to apply for this post. Candidates belonging to Other Backward Communities, Scheduled Castes and Scheduled Tribes are eligible for usual age relaxation as per rules. (For other conditions regarding age relaxation please see part 2 of the General Conditions)
- 7 Qualifications** :

M.C.A or B.Tech (Electrical and Electronics/Electronics/Computer Science)

OR

B.Tech (any discipline) with specialisation in Computer i.e., PGDCA or equivalent

OR

B.Tech (any discipline) with minimum one year experience in Data Processing/Software Development.

OR

M.Sc with specialisation in Electronics/Physics/Computer Science/Mathematics/Statistics with minimum one year experience in Data Processing/Software Development

8 **Mode of submitting applications :-**
