GENERAL RECRUITMENT – STATE WIDE

Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

- 1 Department** : **Insurance Medical Services**
- 2 Name of Post** : **Assistant Insurance Medical Officer**
- 3 Scale of pay** : **₹24040-38840**
- 4 Number of vacancies** : **46 (Forty Six) (NJD)**

Note:- Three percentage (3%) of the vacancies are reserved for the Physically Handicapped persons.[As per G.O.(P) No.61/2012/SWD dated 17.10.2012 candidates with Locomotor Disability/Cerebral Palsy, Blindness, Low Vision are eligible for reservation.]

The above vacancies are now in existence. The list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies noted above and also against the vacancies if any reported to the Commission in writing during the currency of the list.

- 5 Method of appointment** : Direct Recruitment
- 6 Age limit** : Age 21 – 42. Only candidates born between 02.01.1972 and 01.01.1993 (both dates are included) are eligible to apply for this post with usual relaxation to Scheduled Castes, Scheduled Tribes and Other Backward Communities. (for other conditions regarding the age relaxation please see part 2 of the General Conditions.)

7 Qualifications

- 1 Degree in Modern Medicine or equivalent qualification.
(Equivalent qualification means those qualifications recognised as equivalent by the Medical Council of India.)
- 2 Valid Registration with the Travancore-Cochin Medical Council

Note: 1. Rule 10(a)(ii) of Part II KS & SSR is applicable.

2. Those who are appointed in the post should serve for four (4) years during first 10 years of their service (including the period of training) anywhere in India or any Foreign Country under defence service or services connected with defence. Those who have completed 45 years of age are exempted from the above compulsory Medical Service.

8. Mode of Submitting applications:

Before applying for the post, candidates should register as per “ONE TIME REGISTRATION” Scheme through the Official website of Kerala Public Service Commission www.keralapsc.gov.in. Those who have already registered can apply by logging in to their profile using his/her User-ID and Password. No application fee is required. Candidates can view, rectify defects and print the details in the registration card by clicking the link **Registration Card** after entering the home page. Candidate are responsible to ensure correctness of the personal information and secrecy of password and they shall keep in mind the user ID for further communication with the Commission. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected. Documents to prove qualification, age, community etc have to be produced as and when called for.
