- (v) The candidates belonging to above reservation communities shall submit application for this post to the district concerned where the vacancy is in existence for their respective community and shall note the name of that district against the relevant column in the online application.
- (vi) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in GO(Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to

another district unless he completes five years of continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in GO(MS) No. 4/61/PD dated, 2.1.1961. Candidates already in Government service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

- 5. Method of appointment: Direct Recruitment (From candidates belonging to Hindu Nadar and Scheduled Caste communities only).
- 6. Age limit (i) <u>Hindu Nadar</u>: 19-39 Candidates born between 02.01.1975 and 01.01.1995 (both dates included) are eligible to apply for this post.
 - (ii) <u>Scheduled Caste.</u> 19-41 Candidates born between 02.01.1973 and 01.01.1995 (both dates included) are eligible to apply for this post. (including the age relaxation as per Para 2 (i) of General conditions).

Note:- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para 2 of General Conditions under Part II of this notification.

7. Qualifications:-

(1) Must have passed SSLC Examination or its equivalent.

Note :- KS&SSR Part II Rule 10 a (ii) is applicable.

(2) Must not be less than 162 cms in height and 79 cms round the chest and must have a chest expansion of 5 cms on full inspiration.

Note:-

- (i) For candidates belonging to SC/ST, the minimum height prescribed is relaxable by 2.5 cms.
- (ii) Preference will be given to Ex-home Guards within the meaning of G.O (MS) No 50/70/PD dated 12.02.1970.
- (iii) Preference will be given to Ex-Servicemen subject to rules.
- (iv) Women and Physically handicapped persons are not eligible to apply. Hence part (vii) of para 2 and para 5 of general conditions are not applicable to this post.
- (v) NCC cadets having `A', `B', `C' Certificate will be given weightage of marks at the rate of 2%, 3% and 5% respectively vide G.O (MS) No 112/2007/H.Edn dated 21.08.07.

8. **Mode of submitting application:**
