- (i) Candidates shall apply through online application available in the website of KPSC Viz. www.kerala psc.gov.in. Conventional type applications for the above post will be summarily rejected.
- (ii) A ranked list will be prepared for Wayanad district in pursuance of this notification. The ranked list thus prepared and published by the Commission shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be inforce till the publication of a new list, after the expiry of the minimum period of one year, or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancy and also against the vacancies, if any reported during the currency of the list. In case no candidate is advised from the ranked list till the expiry of the period of one year or till atleast one candidate is advised from the list, whichever is earlier.
- (iii) Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction and if he/she is selected, his/her name will be removed from the ranked list and disciplinary action will be taken against him/her. Candidates should note the name of the district concerned, against the relevant column of the online application.
- (iv)The selection in pursuance of this notification will be made on a Revenue district basis, subject to the Special conditions laid down in G.O(MS) No. 154/71/PD dated 27.05.1971. A candidates advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years it will be subject to the rules in G.O(MS) No. 4/61/PD dated 02.01.1961. Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
