Ranked List thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of new lists after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised and appointed against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidate is advised from the ranked lists till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.

- (2) Application should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction and if he/she is selected his/her name will be removed from the ranked lists and disciplinary action will be taken against him/her. Candidates should note the name of concerned District against the relevant column of the online application.
- (3) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O. (Ms) No 154/71/PD dated, 27-05-1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes 5 years continuous

service from the date of commencement of service in the former district. Even if transfers is allowed after five years, it will be subject to the rules in G.O. (MS) No. 4/61/PD. dated, 21.01.1961. Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

A pass in VHSE in Medical Laboratory Technician

Note: - Physically disabled persons (Locomotor disability/Cerebral Palsy, Hearing impairment, low vision) are eligible for 3% appointment as per G.O(P)No. 1/13/SJD dated 03.01.2013.
