- (i) Conventional type applications will be summarily rejected. Candidates shall apply only through online application available at the Kerala Public Service Commission Website viz. www.keralapsc.gov.in
- (ii) Separate ranked list will be prepared for each district in pursuance of this notification. The ranked lists thus prepared and published by the Commission shall remain in force for a minimum period of one year subject to the condition that the said lists will continue to be in force till the publication of a new list, after the expiry of the minimum period of one year or till the expiry of 3 years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies if any, reported during the currency of the list. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the Ranked List shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
- (iii) Applications should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction and if he/she is selected, his/her name will be removed from the ranked lists and disciplinary action will be taken against him/her. Candidates should submit
