**7. Qualifications: -**

First Class or Second Class degree with not less than 55 % marks or Second class Master's Degree in Painting from a recognised university.

OR

a) Pass in S.S.L.C. or equivalent qualification.

b) First Class or Second Class National Diploma (Equivalent to degree) with not less than 55% marks in Painting from a recognised University or Institution.

**Preferential :** Participation in major exhibitions, one man show and group shows, preference being given within the meaning of G.O. (MS)50/70/PD dated 12.02.70 as amended.

**8. Mode of submitting Applications:**

Candidates shall register as per 'ONE TIME REGISTRATION ' on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' for applying for the post. Candidates who have already registered shall apply by logging in to their profile using their User- ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification link for a post. No application fee is required.
