- 1) M.Sc (Nursing) or B.Sc Nursing (Basic or Post basic) from a recognized University.
- 2) Certificate of Registration with the Kerala Nurses & Midwives Council as Nurse & Midwife in the case of Women candidates or as Nurse in the case of Male candidates.

Note:

- 1) Every person appointed as Nursing Tutor be on probation for a total period of two years on duty within a continuous period of three years.
- 2) Every person appointed as Nursing Tutor shall during the period of probation, pass the Account Test for Executive Officers(Kerala)or Account Test (Lower), if he/she has not already passed the tests.

8. Mode of submitting Application:

- Before applying for the post, candidates shall register as per “ONE TIME REGISTRATION” system on the Official Website of Kerala Public Service Commission ‘www.keralapsc.gov.in’. Those who have already registered can apply by logging on to their profile using their User-Id and pass word. No application fee is required. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected.
