THIRD N.C.A. NOTIFICATION (SOCIETY CATEGORY)

Applications are invited online only by One Time Registration from qualified regular employees belonging to Scheduled Caste of the Member Societies affiliated to Kerala State Handloom Weaver's Co-operative Society Limited (HANTEX) for appointment in the under mentioned post. The photo uploaded through One Time Registration should be the one taken within one year from the date of uploading. This instruction is applicable to the photographs produced by the candidates as per the direction of the Commission at any stage of selection.

- 1 Name of concern : Kerala State Handloom Weaver's Co-operative Society Limited (HANTEX)
- 2 Name of post : Lower Division Clerk
- 3 Scale of Pay : ₹ 3050 – 5230/- (PR)
- 4 Number of Vacancies : Scheduled Caste 1 (One)

Note:- (i) The above vacancy is now in existence. This is the third N.C.A. Notification published due to the non availability of SC candidates in the Ranked List for the post of Lower Division Clerk that came into effect on 09.08.2011 (Category No.352/2008). The Ranked List published as per this notification will be valid until filling up the vacancy that arose due to the absence of SC candidates in the Ranked List published in the above said date. Vacancies that arise/may arise which are earmarked for SC candidates, during that period will also be filled up from this Ranked List.

(ii) In the absence of qualified Scheduled Caste candidates, Scheduled Tribe candidates will also be considered.

(iii) The selection in pursuance of this notification will be made on statewide basis.

5. Method of appointment : Direct Recruitment from qualified regular employees belonging to Scheduled Caste of the Member Societies affiliated to Kerala State Handloom Weavers Co-operative Society Limited (HANTEX).

Note:- Applications submitted by candidates who are not regular employees of HANTEX and belonging to communities other than Scheduled Caste will be rejected.

Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. Age : 18-50 years. Candidates born between 02.01.1964 and 01.01.1996 (Both dates included) are only eligible for the post.

7. Qualifications:

1) Must be a regular employee who has a minimum regular service of 3 (three) years and continuing in service in any cadre in the Member Co-operative Societies affiliated to the Kerala State Handloom Weaver's Co-operative Society Limited (HANTEX).

2. B.A./B.Sc./B.Com. Degree from a recognized University with HDC/HDC&BM/JDC.

OR

B.Com. With Co-operation.

OR

B.Sc. Co-operation & Banking of Kerala Agricultural University.

8. The eligible employees of Kerala State Handloom Weaver's Co-operative Society Limited (HANTEX) who apply for the above post should obtain the Service Certificate from the Assistant Registrar (General) showing the details of service of the applicant, which render them, eligible to apply for the post and shall be produced when required by the Commission. Candidates can view, rectify defects and have a print-out copy of the details in the registration card by clicking the link Registration Card after entering their Home Page. Candidates are responsible for the correctness of the personal information and secrecy of password and they shall commit to memory the User-ID for further communication with the Commission. Applications submitted not in accordance with the instructions on the website will be summarily rejected. Documents to prove qualification, age, community etc. have to be produced as and when called for.
