FIRST NCA NOTIFICATION

Applications are invited from qualified candidates of Scheduled Caste, Scheduled Tribe and Hindu Nadar Communities for selection to the following post. Applications must be submitted online only through the official website of the Commission after “ONE TIME REGISTRATION”. Candidates who have already registered can apply through their profile.

1. Name of Firm : Various Government owned Companies/Corporations/Boards
2. Name of Post : Security Guard/Security Guard Gr.II/Watcher Gr. II
3. Scale of Pay : Scale of pay as prescribed for the post by the Company/Corporation/Board concerned
4. No. of vacancies : Scheduled Caste- 2, Scheduled Tribe-1, Hindu Nadar - 1

Note:-

- (i) The number of candidates to be included in the short list/probability list of the above post will be decided as per the availability of admitted applications.
- (ii) The above vacancies are now in existence. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the above vacancies earmarked for Scheduled Caste, Scheduled Tribe, Hindu Nadar which remained unfilled due to the paucity of SC, ST, Hindu Nadar candidates during the currency of the Ranked List published on 16.10.2012 for the post notified as, Category No. 291/07.
- (iii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On

such cancellation the appointing authority shall terminate the service of the candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

5. Method of appointment : Direct Recruitment from candidates belonging to SC, ST, Hindu Nadar communities only

Note: The applications submitted by candidates other than those belonging to SC, ST, Hindu Nadar communities will be summarily rejected. No rejection memo will be issued to them individually.

6. Age : 18-45. (Only candidates born between 02/01/1969 and 01/01/1996 (both dates included) are eligible to apply for this post with usual age relaxation for SC, ST, Hindu Nadar communities.

Note:- 1. The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided, they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

7. Qualifications:

- (1) Pass in Standard VII (new) or its equivalent examination
- (2) Not less than 3 years experience in the Armed Forces viz. Army/ Navy/Air Force
- (3) Knowledge of cycling
- (4) Height – 168 cms.
- (5) Chest – Normal 81 cms with minimum 5 cms expansion

Note: Women are not eligible to apply for the post.

8. Mode of submitting applications:-

Candidates shall register as per “ONE TIME REGISTRATION” system on the official website of Kerala Public Service Commission ‘www.keralapsc.gov.in’ for applying for the post. Those who have already registered can apply by logging on to their profile using their User ID and password. Candidates shall click on the ‘Apply Now’ button of the respective post in the Notification link for applying for a post. No application fee is required. Candidates can view and have a print-out of the details in the profile if required by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of the password. Before applying for a post, candidates must ensure the correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove Qualification, Community, Age, etc. have to be produced as and when called for.

9. Last date for receipt of application : **31.12.2014**, Wednesday upto

12.00 midnight.
