Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

Note: (i) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued.

- (ii) Separate Ranked List will be prepared for Idukki district in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

- (iii) Reservation community candidates shall submit application for the post to the concerned district officer where the vacancy is existing for their respective community and note the name of that district against the relevant column of the on line application.

(iv) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms) No.154/71/PD dated, 27-05-1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district, unless he completes five years continuous service from the date of commencement of service in the former district . Even if transfer is allowed after five years, it will be subject to the rules in G.O. (MS) No. 4/61/PD. dated, 02.01.1961. Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5 **Method of Appointment** : Direct Recruitment. (from candidates belonging to Ezhava/Billava/Thiyya Community only).

6 **Age Limit** : 18-43. Only candidates born between 2.01.1970 and 01.01.1995 (both dates included) are eligible to apply for this post .
[Including the relaxation as per para 2(i) of the general conditions].

Note: - For conditions regarding other age relaxation please see para 2 of the general conditions except para 2(i)

7. **Qualifications:-**

- 1) A pass in S.S.L.C Examination conducted by the Commissioner for Government Examinations, Kerala or its equivalent.

OR

A pass in Pre-degree Examination conducted by any of the Universities in Kerala or any examinations recognized by any such Universities as equivalent to

Pre-degree examination.

OR

A pass in Higher Secondary Examination conducted by the Board of Higher Secondary Examinations, Kerala or any other examinations, recognized by Government as equivalent thereto.

AND

2) A pass in TTC (Tamil) Examination conducted by the Commissioner for Government Examinations, Kerala.

OR

A Degree in any subject & B.Ed/B.T/L.T (in Tamil) conferred or recognized by the Universities in Kerala

Note:- 1) In the absence of candidates with TTC (Tamil) of Kerala, and B.Ed Tamil holders from the Universities in Kerala, candidates with TTC (Tamil) of Madras or candidates with Diploma in Teacher Education (Regular) of Tamilnadu Government shall be considered for appointment.

2) Question paper for the written test, if any, will be in Tamil. The candidates should answer the questions in Tamil.

8. Special Concessions Regarding Appointment And Age Limit.

(i) Preference will be given as laid down in G.O. (MS) No.50/70/PD dated 12.02.1970 and G.O.(MS) No.9/78/G.Edn. Dated 21.01.78 to the wives of jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base establishment are included under the term 'jawans'. Wives of jawans must select "Are you entitled to any priority" as 'yes' on online application and give the details in the space that follows. Such candidates should obtain proper certificates from the Officer Commanding stating the Name, Military rank and Military address of their husbands and produce the same as and when required by the Commission (G.O (MS) No. 509/64/Edn. Dated 19.9.1964, G.O.(MS) No.614/65/Edn, Dated 09.11.65 and G.O.(MS) No.243/66/Edn, Dated 27.05.66).

(ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O. (MS) No.122/75/G.Edn. Dated 27.05.1975 and G.O (MS) No. 50/70/PD dated 12/02/1970).

Note: - The candidates who claim concessions on the basis of any of the reasons mentioned in para (2) of General Conditions should select. “Are you eligible for age relaxation” as “yes” on the online applications and give details in the space following. Otherwise the applications are

liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule should not exceed 50 years of age. (See para 2 of General conditions).

10. Mode of submitting applications:-

Candidates must register as per “ONE TIME REGISTRATION” with the official website of Kerala Public Service Commission viz. www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post., No application fee is required. Candidates can view and have a print out of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of the password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote the User – ID for further communication with the Commission. Applications submitted will be received as provisional and particulars cannot be deleted or altered after submission. The application will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, community, age etc. have to be produced as and when called for.
