### **FIRST NCA NOTIFICATION**

Applications are invited online only exclusively from qualified candidates belonging to Viswakarma community of Kerala State for appointment in the under mentioned post. Application must be submitted on line through the official website of Kerala Public Service Commission after 'One Time Registration'.

1. Department : Excise
2. Name of post : Driver (HDV)
3. Scale of pay : 9190 - 15780/-
4. Number of vacancies : Community wise

**Note :-**

- (i) Conventional type application for the above post will be summarily rejected. Candidates can apply through online application available at the Kerala Public Service Commission website viz. [www.keralapsc.gov.in](http://www.keralapsc.gov.in)
- (ii) Applications submitted by candidates belonging to the community other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.
- (iii) Seperate Ranked list will be prepared for Idukki District in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

- (iv) Reservation community candidates should submit application for the post to the concerned district where the vacancy is in existing for their respective community and shall note the name of that district against the relevant column.
- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(MS)No. 4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, bu

they can apply to higher posts when notified.

5. **Method of appointment** : Direct Recruitment (From candidates belonging to above reservation community only.
6. Age limit : 21- 42 (Including the relaxation as per Para 2(i) of general conditions) Only candidates born between 2.1.1972 and 1.1.1993 (both dates included) are eligible to apply for this post.

Note: For other conditions regarding age relaxation, please see para (2) of the General Conditions except para 2 (i). (Subject to the condition that the maximum age limit shall in no case exceed 50 years)

7. **Qualifications:-**

- 1 A Pass in Standard VII (New) or its equivalent.
- 2 Must possess valid Heavy Duty Driving Licence of three years standing with endorsement for driving HP & HG Vehicles and Badge.
- 3 Proficiency in Driving Heavy goods/passenger Motor Vehicles which is to be proved by a practical test including H test and road test conducted by Kerala Public Service Commission during the course of selection. Only those who have passed 'H' test are eligible for Road Test.

Note:- KS&SSR Part II Rule 10 (a) ii is applicable.

- 4 **Physical Fitness:-** Must not be less than 165 Cm in height and 83 Cm round the chest with a minimum expansion of 4 Cm.

(c) Muscles and joints : No paralysis, all joints with free movement.

(d) Nervous System : Perfectly normal and free from any infectious diseases.

**Note :-**

- (a) Candidates called for practical Test will have to produce a Medical Certificate in the prescribed form in original containing all relevant details as mentioned in item No 4 [except 5 (b) in para 7 above from a Medical Officer not below the rank of an Assistant Surgeon. A Medical certificate regarding eye sight mentioned in 5 b in para 7 above from an Ophthalmologist in Government Service also will have to be produced.
- (b) The Candidates will have to furnish the full details regarding the Driving Licence alongwith qualification in the application.
- (c) Physically Handicapped candidates are not eligible to apply for the post.

- (d) Candidates should possess a current valid Driving Licence and badge on all the stage of selection process namely on the last date of receipt of application, OMR test on the date of practical test, interview etc.

Probation:- Every person appointed to the post shall from the date on which he joins duty be on probation for a total period of 2 years on duty within a continuous period of 3 years.

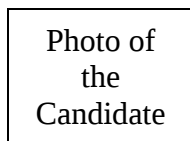

### **8. Mode of Submitting Applications:-**

Candidates must register as per “ONE TIME REGISTRATION” with the official website of Kerala Public Service Commission viz. They must quote the User – ID for further communication with the Commission. Applications submitted is provisional and cannot be deleted or altered on after submission. The application will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.
