Applications are invited online only from qualified candidates for appointment in the under mentioned post in Kerala Government Service. Before applying for the post candidates should register as per the One Time Registration through the official website of Kerala Public Service Commission.

1. Department : Vocational Higher Secondary Education
2. Name of Post : Vocational Teacher in Dairying (Milk Products)
3. Scale of pay : ₹ 19240-34500/-
4. No.of vacancies : 1 (One)

The above vacancy is now in existence. The list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies noted above and the vacancies that may be reported to the Commission in writing during the period of currency of the list.

Note:

3% of the vacancies shall be reserved for physically handicapped candidates (Locomotor Disability/Cerebral Palsy, Low Vision, Hearing Impairment) for recruitment to the post as per G.O(P)No.61/2012/SWD dated 17.10.2012.

5. Method of appointment : Direct Recruitment
6. Age limit : 23-40
Only candidates born between 02.01.1974 and 01.01.1991 (both dates included) are eligible to apply for this post with usual relaxation to Scheduled Castes, Scheduled Tribes and Other Backward Communities. (for other conditions regarding the age relaxation please see part 2 of the General Conditions)
7. Qualification : Degree in Dairy Technology with not less than 60% marks from Kerala Agricultural University or an equivalent qualification;
OR
Pass in M.Sc. Agriculture Dairy Science with not less than 50% marks from any of the recognised Universities;
OR
Degree in Veterinary Science and Animal Husbandry with not less

than 60% marks from Kerala Agricultural University or an equivalent qualification.

Note :- 1) Rule 10(a)ii of Part II, KS&SSR is applicable.

- 2) In the appointment of Vocational Teacher preference will be given to persons having additional qualification of Diploma in Computer Application from a recognised Institution.
- 3) All the Educational qualifications for teaching posts should be one acquired after a regular course of study from a recognised University in Kerala or recognised as equivalent thereto by any of the Universities in Kerala.

8. Mode of submitting Applications :

Before applying for the post, candidates should register as per "ONE TIME REGISTRATION" through the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in'. Those who have already registered can apply by logging into their profile using his/her User-id and password. No application fee is required. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected.
