NCA NOTIFICATION

Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

Note: (1) Applications submitted by candidates belonging to the community other than that notified will be summarily rejected. No rejection memo will be issued.

(2) Separate Ranked list will be prepared for Palakkad District in pursuance of this notification. Ranked list thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

(3) Candidates shall submit application for the post to Palakkad district where the vacancy is in existence for their community and shall note the name of that district against the relevant column of the online application.

(4) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O. (Ms) No 154/71/PD dated, 27-05-1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O. (MS) No. 4/61/PD. dated, 21.01.1961. Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified. Candidates who secure appointment in the Head Quarters vacancies will be eligible for transfer subject to the conditions prescribed in GO (MS) No. 422/80/GAD dated 26.09.1980.

5 Method of Appointment : Direct Recruitment (from candidates belonging to ST Community only)

6. **Age Limit** : 19-41, Only candidates born between 02.01.1972 and 01.01.1994 (both dates included) are eligible to apply for this post. Including the relaxation as per para 2(1) of General condition.

Note: - For conditions regarding other age relaxation please see para 2 of the general conditions except 2(i).

7. **Qualifications:-**

A pass in SSLC or equivalent examination with not less than 60% marks in Mathematics.

OR

A Computer Certificate ABC of the Indian Statistical Institute, Calcutta

OR

A National Diploma in Commerce.

Note: - (1) 60% Marks in Mathematics in SSLC will not be insisted upon in the case of Last Grade Servants employed in the Economics and Statistics Department and in the case of Graduates in Mathematics, Economics, Statistics or Commerce.

(2) Candidates should note the percentage of marks secured for mathematics in the SSLC Examination. Candidates who do not possess 60% marks in Mathematics for SSLC and who possess degree in Economics, Mathematics, Statistics, Commerce must note in the application the subject of the degree possessed in brackets.

8. Mode of submitting application:

Candidates must register as per “ONE TIME REGISTRATION” with the official website of Kerala Public Service Commission viz. www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to this profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post., No application fee is required. Candidates can view and have a print out of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote the User – ID for further communication with the Commission. Applications submitted is provisional and cannot be deleted or altered on after submission. The application will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.
