OR
2. Diploma in Medical Records Science awarded by Sree Chitra Tirunal Institute for Medical Science and Technology, Thiruvananthapuram.
3. In the absence of (1) and (2) above candidates with Pre-Degree/Higher

Secondary /Plus Two or equivalent qualification with training in Medical Records keeping for one year from a recognised Medical College will be considered.
