Applications are invited from qualified Scheduled Caste/Scheduled Tribe candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be the one taken within one year of the date of uploading. This instruction is applicable to photographs produced by candidates as per the direction of the Commission, at any stage of selection.

- 1 Name of Department** : Commercial Taxes
2 Name of post : Commercial Tax Officer
(Special Recruitment for SC/ST Only)
3 Scale of pay : ₹20,740 – 36,140/-
4 No. of vacancy : 05 (Five)

Note: The above Vacancy is now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from Scheduled Caste/Scheduled Tribe during the currency of the list. Candidates against vacancies exclusively reported for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list that fresh notification for Scheduled Tribes for vacancies reserved exclusively for them will be issued.

5 Method of Appointment : Direct Recruitment (Special Recruitment from among Scheduled Castes/Scheduled Tribes only).

Note: Applications received from candidates other than Scheduled Caste/Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6 Age : 18 - 41
Only Candidates born between 02.01.1973 and 01.01.1996 (both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

Note: In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7 Qualifications:

Graduation with a degree in Law.

OR

A pass in Chartered Accountant (Inter) as defined in the Chartered Accountants Act, 1949 (Central Act 38 of 1949).

OR

Masters Degree in Commerce.

OR

Masters Degree in Business Administration (Finance).

Note: KS&SSR Part II Rule 10 (a)ii is applicable to qualification.

8 Training: Every person appointed to this post shall from the date of appointment undergo such training as may be prescribed by the Government from time to time and will commence probation in the post only after successful completion of the Training. Such person shall until he has completed training be entitled only to such allowances as may be specified by Government from time to time. The period of training shall not count for increment in the time scale of pay applicable to the post

9 Mode of Submitting application:

Candidates must register as per 'One Time Registration' with the official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have already registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link while applying for a post. No application fee is required. Candidates can view, rectify defects and have a printout of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of each application, the candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.
