FIRST NCA NOTIFICATION

Applications are invited online only from qualified candidates of Hindu Nadar communities for selection to the following post. Applications shall be submitted online only on the official website of the Commission after “ONE TIME REGISTRATION”. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be taken within one year of the date of uploading. This instruction is applicable to photographs produced by candidates as per the direction of the Commission, at any stage of selection.

1. Name of Firm : Kerala State Road Transport Corporation
2. Name of Post : Painter Gr. II
3. Scale of Pay : ₹ 3050 – 6075/- (PR)
4. No. of vacancies : Hindu Nadar – 1 (One)

- (1) The number of candidates to be included in the Short List/Probability List of the above post will be decided as per the availability of admitted applications.
- (2) The above vacancy is now in existence. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the Hindu Nadar community but remain unfilled due to the paucity of candidates during the currency of the Ranked List published on 25.03.2014 for the post.
- (3) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

5. Method of appointment : Direct Recruitment for Hindu Nadar community only.

Note: Application submitted by candidates other than Hindu Nadar

community will be rejected. No rejection memo will be issued them individually.

6. Age : 18-39 (Only candidates born between 02/01/1975 and 01/01/1996 (both dates included) are eligible to apply for this post.

Note:- 1. . The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

7. Qualifications:

- (i) Must be able to read and write Malayalam or Tamil or Kannada
- (ii) Must be able to paint letters and to mix paints properly
