Note: (i)

The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It should also be clearly specified in the certificate that they were not working in the regular service of the concern. The overaged candidates who become eligible to be included in the Ranked List on the basis of their provisional service in any Company/Corporation/ Board/Authority/Society will be considered only in the vacancies reported by the same concerned, in which they have worked provisionally.

(ii) The retrenched employees of the Kerala Fisheries Corporation will be given age relaxation as stipulated in the G.O.(Rt)No.1942/84/PW dtd. 31.12.1984 to the extent of their service subject to the condition that the maximum age limit shall not exceed 50 years. These candidates will also be given preference in the matter of recruitment among other candidates with equal marks. (ii) Candidates should possess Current Driving Licence and Badge on the last date for receipt of applications in the office and also on the date of OMR test, Practical Test, Interview and at all stages of selection.

(iii) The proficiency in driving will be assessed by the Commission by conducting a practical test.
